

## PROGRAM OVERVIEW

---

Signature's scholarship program is intended to help enhance the intellectual and personal growth of college and post-graduate students who are legal dependents of current Signature Performance Associates. This will be accomplished through cash awards that help cover the cost of tuition and expenses students will face when continuing their education. The establishment of this program is designed to make the lives of those we work with better.

## SCHOLARSHIP AWARD

---

Each year a limited number of scholarship recipients will be awarded with a one-time scholarship for up to \$2,000, payable to a certified educational institution to be applied toward tuition and fees. This scholarship award does not automatically renew, but can be reapplied for annually.

## ELIGIBILITY REQUIREMENTS

---

Signature Scholarships are open to any dependent child of a Signature Performance Associate who is employed and in good standing during the application period.

For our purposes, child is defined as a person under the age of 24 at the submission deadline who is the biological, adopted or step child or other permanent custodial ward (e.g. custodial grandchild) of a Signature Performance Associate (this award is not available to dependents of contract workers.)

The student must be in good standing with his/her institution of higher education, and be able to submit at least one non-family recommendation to the committee.

## APPLICATION PROCESS

---

- Complete the attached application form.
- Submit an original submission in response to the question posed in the application. Your submission may be one of the following two options:
  1. Original Short Essay
    - 1,000 Word Limit
    - Single-Spaced
    - 12 Point Font Size
  2. Original Video Recording
    - Three to ten minute duration

    - Please keep your background professional and distractions to a minimum.

## SCHOLARSHIP SELECTION CRITERIA

---

- Grade point average – indicate if you are taking AP classes
- Scores on ACT and SAT general tests, SAT subject tests, AP tests (if applicable)
- Honors/Awards – specify the level of award (e.g: school, district, regional or national level award)
- School activities/leadership positions/sports involvement
- Special interests, hobbies, community service

Students are encouraged to document their achievements by providing copies of report cards/transcripts, certificates of achievement, recommendation letters from teachers and/or counselors, etc. Volunteer work can be documented.
